5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2080/07/02 13:00 hrs at the office of Lamkichuha Municipality. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 54000 NRs which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[ 4450100303000002 at Rastriya Banijya Bank, Lamki, Kailali, and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
